1 WHEREAS, the Judicial Branch operates a portion of its adminis-2 tration under a "638" contract at a base level consistent 3 with the approved levels of Congress; and 4 WHEREAS, the BIA has failed to provide funds at the approved levels 5 and has maintained a position contrary to the intentions 6 of Congress; and 7 WHEREAS, this dilemma has resulted in the exhaustion of all 8 available operating funds of the Judicial Branch as of 9 June 30, 1990; and, 10 WHEREAS, the Judicial Branch has submitted a request for additional 11

funds from the Nation; and, WHEREAS, it would benefit the Legislative Council to review an

analysis of all funds received and expended, further, it is necessary to review the legislative history of the Judicial Branch's contract funding.

NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative continue Council that the Judicial Branch its operations until such time that the Legislature has reviewed the legislative history of the Branch's contract funding, and reviewed the funding analysis, and has taken affirmative action on the request for additional funding.

The foregoing Resolution was passed by the Tohono O'odham Council on the 11th day of July, 1990 at a meeting at which a quorum was present with a vote of 1,452.0 for; 272.0 against; -0- not voting; 02 absent, pursuant to the powers vested in the Council by Section 1(d) (2) & (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
