23	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council
24	does support the request of the Sif Oldak District to
25	expedite necessary actions to implement P.L. 99-469.
26	BE IT FINALLY RESOLVED that the Sif Oidak District Council be
27	provided with a financial analysis of the \$100,000.00 plus
28	interest, from the effective date of October 14, 1986.
29	The foregoing Resolution was passed by the Tohono O'odham Council on the 12th day of <u>July, 1990</u> at a meeting at which a quorum was present with a vote of 1,483.0 for; 127.0 against; 114.0 not
30	voting; 03 absent, pursuant to the powers vested in the Council by Section 1 (d) (2) of Article VI of the Constitution of the Tohono
31	O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary -
