NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 1. The Legislative Council hereby approves the attorney contract with the law firm of Rothstein, Bennett, Daly, Donatelli & Hughes, in the form attached hereto.
- 2. The Legislative Council authorizes execution of the attorney contract by the Chairman of the Tohono O'Odham Nation, or his designee, and approval thereof by the Attorney General.
- 3. The Legislative Council directs that all outstanding statements of the Special Counsel on Counsel be first paid from the remaining funds in the Special Counsel budget, with the balance to be paid from the Attorney General's budget devoted to this contract.

The foregoing Resolution was passed by the Tohono O'odham Council on the 13th day of July, 1990 at a meeting at which a quorum was present with a vote of 1,667.0 for; 57.0 against; -0- not voting; 04 absent, pursuant to the powers vested in the Council by Section 2(a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
