Budget Modification #1)

1 WHEREAS, the Tohono O'odham Nation is currently operating the
2 Education Committee with tribal funds; and
3 WHEREAS, amendments affecting the funding level or change in the
4 purpose for which the funds were budgeted are required to
5 be submitted for review and approval by the Tohono O'odham
6 Legislative Council; and
7 WHEREAS, an amendment has been submitted for review and approval.
8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that it hereby approves this amendment to increase
10 the amount by \$12,574.00 and authorizes expenditures in
11 accordance with the attached budget.


12 The foregoing Resolution was passed by the Tohono O'odham Council

14 present with a vote of 1,378.0 for; 346.0 against; -0- not
15 voting; 03 absent, pursuant to the powers vested in the Council
16 by Section 1 (d)(3) of Article VI of the Constitution of the Tohono
17 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
18 1986, and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
20 16 of the Act of June 18, 1934 (48 Stat. 984).




