2 Tribal Garage with tribal funds; and


3 WHEREAS, amendments affecting the funding level or changes in the

7 WHEREAS, an amendment has been submitted for review and approval.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that it hereby approves this amendment
10 transferring funds between line items and authorizes
11 expenditures in accordance with the attached budget.


12 The foregoing Resolution was passed by the Tohono O'odham Council


