

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(O'odham In Mexico Program FY-90
Budget Modification #1)

RES. NO. 264-90

1 WHEREAS, the Tohono O'odham Nation is currently operating the
2 O'odham In Mexico Program with tribal funds; and

3 WHEREAS, amendments affecting the funding level or changes in the
4 purpose for which the funds were budgeted are required to
5 be submitted for review and approval by the Tohono O'odham
6 Legislative Council; and

7 WHEREAS, an amendment has been submitted for review and approval.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that it hereby approves this amendment to increase
10 the amount by \$28,518.51 and authorizes expenditures in
11 accordance with the attached budget.

12 BE IT FURTHER RESOLVED that the Tohono O'odham Nation will not be
13 responsible for expenditures incurred above and beyond the
14 approved attached budget.


15 The foregoing Resolution was passed by the Tohono O'odham Council
16 on the 7th day of August, 1990 at a meeting at which a quorum was
17 present with a vote of 1,050.5 for; 611.0 against; 62.5 not
18 voting; 03 absent, pursuant to the powers vested in the Council
19 by Section 1 (d)(3) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).



32 submittal.


