

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1991 Tohono O'odham Psychological Services  
Contract Extension)

RES. NO. 265-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the  
2 Tohono O'odham Psychological Services Program under FY  
3 1990 P. L. 93-638 contract with Public Health, Indian  
4 Health Services; and

5 WHEREAS, such tribal operations have been successful and beneficial  
6 to the Tohono O'odham Nation and its people; and

7 WHEREAS, the Tohono O'odham Nation does desire to extend the  
8 contract for provision of services during FY 1991; and

9 WHEREAS, the Tohono O'odham Legislative Council has reviewed and  
10 approved the Tohono O'odham Psychological Services Program  
11 FY 1991 contract extension and budget.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
13 Council that it does authorize and request the Indian  
14 Health Service to extend Contract No. 249-90-0002 with the  
15 Tohono O'odham Nation under P. L. 93-638.

16 BE IT FURTHER RESOLVED that the duration of this contract extension  
17 will commence on October 01, 1990 through September 30,  
18 1991.

19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
20 that the Tohono O'odham Nation will not fund or operate  
21 the program in the interim while negotiations are still  
22 being conducted and no executed contract has been awarded  
23 by the Indian Health Service.

24 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
25 that the Tohono O'odham Nation's Officials, to wit: The  
26 Chairman, Vice Chairman and any designated official are  
27 hereby authorized to negotiate and execute the contract,  
28 provided however, that any amendments affecting the  
29 funding or funding levels of this contract shall be  
30 submitted for further prior approval by this Council.

31 The foregoing Resolution was passed by the Tohono O'odham Council  
32 on the 7th day of August, 1990 at a meeting at which a quorum was  
present with a vote of 1,724.0 for; -0- against; -0- not voting;

03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
