WHEREAS, the Tohono O'odham Psychological Services hereby requests \$13,711.00 to supplement the program budget to meet the costs of increased fringe benefits.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative

Council does hereby approve the Supplemental request and
authorizes expenditures in accordance with the attached
budget.
