

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1991 Tohono O'odham Psychological Services Supplemental Request  
to fully fund Fringe Benefits at 28%)

RES. NO. 266-90

1 WHEREAS, the Tohono O'odham Nation by Resolution No. 154-90 has  
2 mandated an increase in fringe benefit costs of an  
3 additional 16% of salaries and wages for all programs; and  
4 WHEREAS, the fringe benefit amount required by the Tohono O'odham  
5 Psychological Services to satisfy this mandate is  
6 \$13,711.00; and  
7 WHEREAS, the Tohono O'odham Psychological Services performed a  
8 budget analysis and determined budgeting for the  
9 additional 16% would have an unacceptable negative impact  
10 in delivery of services by the program; and  
11 WHEREAS, the Tohono O'odham Psychological Services hereby requests  
12 \$13,711.00 to supplement the program budget to meet the  
13 costs of increased fringe benefits.  
14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
15 Council does hereby approve the Supplemental request and  
16 authorizes expenditures in accordance with the attached  
17 budget.

18 The foregoing Resolution was passed by the Tohono O'odham Council  
19 on the 7th. day of August, 1990 at a meeting at which a quorum  
20 was present with a vote of 1,502.5 for; 221.5 against; -0- not  
21 voting; 03 absent, pursuant to the powers vested in the Council  
22 by Section 1 (d)(2)(3) of Article VI of the Constitution of the  
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






