1 WHEREAS, it has become necessary for the San Xavier District to
2 provide additional funds to better serve its
3 constituency; and

4 WHEREAS, it is necessary to modify the current budget of
5 \$442,560.00 by \$71,726.00 to cover added expenses and/or
6 costs as outlined in the attached budget and
7 justification; and


8 WHEREAS, the San Xavier District did by Resolution #11-89-06
9 approved to increase its current budget from \$442,560.00
10 to \$514,286.00; and

11 WHEREAS, the Tohono O'Odham Legislative Council has reviewed and
12 approves of same.


13 NOW, THEREFORE, BE IT RESOLVED that the San Xavier District FY '90
14 budget be increased by \$71,726.00 thereby increasing the
15 total to \$514,286.00 for Fiscal Year 1990.

16 The foregoing Resolution was passed by the Tohono O'odham Council
17 on the 5th day of February, 1990 at a meeting at which a quorum was
18 present with a vote of 1,201.5 for; 116.5 against; 406.0 not
19 voting; 01 absent, pursuant to the powers vested in the Council
20 by Section 1 (d)(3) of Article VI of the Constitution of the Tohono
21 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
22 1986, and approved by the Acting Deputy Assistant Secretary -
23 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
24 16 of the Act of June 18, 1934 (48 Stat. 984).


