

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Road Priorities FY '90)

RES. NO. 269-90

1 WHEREAS, the Natural Resource Committee did review the B.I.A.  
2 proposed Road Construction and improvements for 1990 to  
3 1995; and

4 WHEREAS, there is a need to construct new roads and improve  
5 existing roads; and

6 WHEREAS, bus routes must be improved and/or constructed; and

7 WHEREAS, the Natural Resource Committee has identified sixteen (16)  
8 routes which need to be improved or constructed; and

9 WHEREAS, there are some roads on the reservation which are not in  
10 the B.I.A. system which should be included on the B.I.A.  
11 System.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation that  
13 the following routes are prioritized and identified as the  
14 following:

- 15 1. Pisinemo Rt. 21
- 16 2. Poso Redondo Rt. 5
- 17 3. Sells Rt. 101 - 2 loops
- 18 4. Little Tucson Rt. 16 Artesia Rt. 161
- 19 5. Baboquivari Rt. 119 West Topawa
- 20 6. Chukut Kuk (Vamori) Rt. 2
- 21 7. Fresnal Loop
- 22 8. San Xavier Traffic Signs
- 23 9. White Horse Pass Rt. 48
- 24 10. Sikal Himatha (Gu Achi District)
- 25 11. Pisinemo Gu Vo Rt. 28
- 26 12. Garcia Strip
- 27 13. East Chui Chu Rt. 50 & Chui Chu Village Loop  
(to be paved)
- 28 14. Jackrabbit Rt. 15
- 29 15. Boys Ranch
- 30 16. Mountain Village


33 BE IT FURTHER RESOLVED that the Chairman or his designee is

4 voting; 03 absent, pursuant to the powers vested in the Council  
5 by Section 1 (j) of Article VI of the Constitution of the Tohono  
6 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
7 1986, and approved by the Acting Deputy Assistant Secretary -  
8 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
9 16 of the Act of June 18, 1934 (48 Stat. 984).




