

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Appropriation of P. L. 99-503 Funds
for Purchase of Health Vehicles)

RES. NO. 276-90

1 WHEREAS, the San Lucy District has recognized its right to address
2 the health needs and well-being of its membership as
3 identified in the way it is seen; and
4 WHEREAS, the San Lucy District has in its membership some health
5 patients who are handicapped and disabled due to the high
6 rate of diabetes and kidney failure disease; and
7 WHEREAS, the San Lucy District has determined that it is in the
8 best interest of the District and its membership to
9 purchase two (2) health vehicles that would be specially
10 equipped to meet the needs of the health patients; and
11 WHEREAS, the San Lucy District has determined that it is in the
12 best interest of the District and its membership to
13 implement and fund for the purchase of the health vehicles
14 utilizing Public Law 99-503 Settlement Funds; and
15 WHEREAS, the San Lucy District Council did authorize, by Resolution
16 No. 07-48-90, the allocation of Public Law 99-503
17 Settlement Funds in the amount of \$41,161.17 in order to
18 fund the purchase of the health vehicles; and
19 WHEREAS, the Tohono O'odham Legislative Council does recognize the
20 health needs of the San Lucy District; and
21 WHEREAS, the Budget and Finance Committee did review the
22 Appropriation Request of the San Lucy District on July 30,
23 1990 and recommends approval.
24 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
25 Council has determined that it is appropriate, and in the
26 best interest of the Tohono O'odham Nation and San Lucy
27 district to authorize the allocation of Public Law 99-503
28 funds in the amount of \$41,161.17 to fund the purchase of
29 health vehicles for San Lucy District.
30 The foregoing Resolution was passed by the Tohono O'odham Council
31 on the 9th day of August, 1990 at a meeting at which a quorum was
32 present with a vote of 1,724.0 for; -0- against; -0- not voting;
02 absent, pursuant to the powers vested in the Council by Section
1 (d)(2) of Article VI of the Constitution of the Tohono O'odham

1 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
2 and approved by the Acting Deputy Assistant Secretary - Indian
3 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
4 the Act of June 18, 1934 (48 Stat. 984).
