3	additional 16% of salaries and wages for all programs; and
4	WHEREAS, the fringe benefit amount required by the Head Start
5	Program to satisfy this mandate is \$60,457.00; and
6	WHEREAS, the Head Start Program performed a budget analysis and
7	determined budgeting for the additional 16% would have an
8	unacceptable negative impact in delivery of services by
9	the program; and
10	WHEREAS, the Head Start Program hereby request \$60,457.00 to
11	supplement the program budget to meet the costs of
12	increased fringe benefits.
13	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
14	Council does hereby approve the Supplemental request and
15	authorizes expenditures in accordance with the attached
16	budget.

18	was present with a vote of 1,445.5 for; 221.5 against; 57.0 not voting: 02 absent, pursuant to the powers vested in the Council

20	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
