

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointment of Housing Commissioners)

RES. NO. 280-90

1 WHEREAS, the Tohono O'odham Executive Branch and the Legislative
2 Council, in a joint solicitation on April 16, 1990, did
3 request Districts of the Nation to recommend individuals
4 for consideration for appointment to the Board of
5 Commissioners for the Tohono O'odham Housing Authority;
6 and

7 WHEREAS, three of the Nation's Districts, specifically, the Chukut
8 Kuk, Gu Achi and Sells District did submit the following
9 names for consideration:

10 Chukut Kuk District: Ms. Harriet Toro

11 Gu Achi District: Mr. Joe Cruz
12 Ms. Ida Pablo

13 Sells District: Ms. Lucille Encinas
14 Mr. Norbert Manuel
15 Ms. Elizabeth Juan
16 Mr. George Ignacio, Sr.

17 WHEREAS, the Tohono O'odham Legislative Council's Housing
18 Committee, subsequent to review of the Districts'
19 recommendations, has recommended that the following be
20 appointed to the Board:

22 Mr. Norbert Manuel
23 Ms. Elizabeth Juan
24 Mr. Joe Cruz
25 Ms. Ida Pablo

26 WHEREAS, it is in the best interest of the Nation that appointments
27 for the Board of Commissioners be made as soon as
28 possible; and

29 WHEREAS, Article IV, Section 4 (b) of the October 26, 1962,
30 "Ordinance Amending Ordinance Establishing the Housing
31 Authority," provides four (4) year staggered terms and
32 further provides that, ". . . one member's term shall be
designated to expire in one year, another to expire in two
years, and a third to expire in three years and the last
two in four years . . ."

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
Council does appoint the following to serve as the Board

13 Four-year Term: Joe Cruz

14 The foregoing Resolution was passed by the Tohono O'odham Council
15 on the 9th. day of August, 1990 at a meeting at which a quorum was
16 present with a vote of 1,111.5 for; 373.5 against; 239.0 not
17 voting; 01 absent, pursuant to the powers vested in the Council
18 by Section 1 (b) of Article VI of the Constitution of the Tohono
19 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
20 1986, and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
22 16 of the Act of June 18, 1934 (48 Stat. 984).



submittal.


