6 Juan; and


7 WHEREAS, the Housing Ordinance, Section IV (Organization) states
8 that "the Council shall name one of the Commissioners as
9 Chairman of the Board"; and

10 WHEREAS, the Legislative Housing Committee recommends Lucille
11 Encinas as Chairman of the Board.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative
13 Council that it does hereby name and appoint Lucille
14 Encinas as Chairman of the Housing Board of Commissioners.


15 The foregoing Resolution was passed by the Tohono O'odham Council

20 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
and approved by the Acting Deputy Assistant Secretary - Indian
Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).




