

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Restated Plan of Operation for the  
Tohono O'Odham Farming Authority

RES. NO. 283-90

1 WHEREAS, the Papago Council, predecessor of the Tohono O'Odham  
2 Legislative Council, did on August 24, 1979, by Resolution  
3 No. 72-79, adopt a Plan of Operation for the Papago  
4 Farming Authority ("Authority") and did thereby create and  
5 establish the legal existence of the Authority; and

6 WHEREAS, since the creation of the Authority, the Legislative  
7 Council has on occasion amended the original Plan of  
8 Operation, in order, inter alia, to increase its borrowing  
9 power and to change its name to Tohono O'odham Farming  
10 Authority; and

11 WHEREAS, in order to meet the requirements of the new Constitution  
12 of the Tohono O'Odham Nation and to facilitate the  
13 management and operation of the Authority, the Management  
14 Board of the Authority has recommended certain amendments  
15 to the Plan of Operation which are incorporated into a  
16 Restated Plan of Operation which, inter alia, (1) will  
17 alter the method by which the directors of the Management  
18 Board are appointed, (2) will add certain fiscal and audit  
19 control provisions to the Plan of Operation, and (3) will  
20 clarify the criteria for computing and distributing the  
21 net profits of the Authority; and

22 WHEREAS, the Agriculture Committee of the Legislative Council has  
23 reviewed the Restated Plan of Operation and has  
24 recommended adoption thereof.

25 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
26 Council that it does hereby approve the amendments to the  
27 Plan of Operation of the Tohono O'Odham Farming Authority  
28 contained in the Restated Plan of Operation, and does  
29 hereby adopt the Restated Plan of Operation of the Tohono  
30 O'Odham Farming Authority, originally known as the Papago  
31 Farming Authority.




