

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Pisinemo District Two (2) Month Budget FY 1990 - EXTENSION)

RES. NO. 284-90

1 WHEREAS, the Pisinemo District Council of the Pisinemo District did
2 on July 28, 1990, by District Resolution 03-90, approve
3 to extend their District Budget in the amount of Eighteen
4 Thousand One Hundred Fifty-three Dollars and Seventy-three
5 cents (\$18,153.73); and

6 WHEREAS, the extension would add on \$18,153.73 to Legislative
7 Council Resolutions 227-89, 05-90, and 118-90 in the
8 amount of \$53,323.00; \$41,333.80 and \$17,315.00; and

9 WHEREAS, the Pisinemo District has sufficient funds in their
10 District Account, on deposit with the Tohono O'odham
11 Accounting Department, to cover their proposed extension;
12 and

13 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
14 Pisinemo District budget and proposed extension, which is
15 attached, and finds it in order.

16 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
17 Council that it hereby approves the Pisinemo District 2-
18 month extension request as presented in the amount of
19 Eighteen Thousand One Hundred Fifty-three Dollars and
20 Seventy-three cents (\$18,153.73) and authorizes
21 expenditures in accordance therewith.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 10th. day of August, 1990 at a meeting at which a quorum
24 was present with a vote of 1,724.0 for; -0- against; -0- not
25 voting; 01 absent, pursuant to the powers vested in the Council
26 by Section 1 (d)(3) of Article VI of the Constitution of the
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
