2 their membership in the Tohono O'Odham Nation, namely:



9 deleted from the membership roll.


10 The foregoing resolution was passed by the Tohono O'odham Council

16 18, 1986, and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
18 16 of the Act of June 18, 1934 (48 Stat. 984).


