

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham FY 1991 Community Health Services)

RES. NO. 295-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Community Health Services Program under FY 1990 P. L. 93-
3 638 contract with the Public Health, Indian Health
4 Services; and

5 WHEREAS, such tribal operations have been successful and beneficial
6 to the Tohono O'odham Nation and its people; and

7 WHEREAS, the Tohono O'odham Nation does desire to extend for
8 provisions of services during FY 1991; and

9 WHEREAS, the Tohono O'odham Legislative Council has reviewed and
10 approved the Community Health Services Program FY 1991
11 extension and budget.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that it does authorize and request the Public
14 Health, Indian Health Service to extend Contract No.
15 249-88-0011 with the Tohono O'odham Nation for services
16 titled: Community Health Services.

17 BE IT FURTHER RESOLVED that the duration of this contract shall
18 commence on October 01, 1990 through September 30, 1991.


19 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20 that the Tohono O'odham Nation will not fund or operate
21 the program in the interim while negotiations are still
22 being conducted and no executed contract has been awarded
23 by the Indian Health Service.

24 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
25 that the Tohono O'odham Nation's Officials, to wit: The
26 Chairman, Vice Chairman and any designated official are
27 hereby authorized to negotiate and execute the contract,
28 provided however, that any amendments affecting the
29 funding or funding levels of this contract shall be
30 submitted for further prior approval by this Council.


31 The foregoing Resolution was passed by the Tohono O'odham Council

was present with a vote of 1,610.0 for; 114.0 against; -0- not
voting; 02 absent, pursuant to the powers vested in the Council

1 by Section 1 (f) of Article VI of the Constitution of the Tohono
2 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
3 1986, and approved by the Acting Deputy Assistant Secretary -
4 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
5 16 of the Act of June 18, 1934 (48 Stat. 984).




