

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1991 Community Health Services Supplemental Request
to Fully Fund Fringe Benefits at 28%)

RES. NO. 296-90

1 WHEREAS, the Tohono O'odham Nation by Resolution No. 154-90 has
2 mandated an increase in fringe benefit costs of an
3 additional 16% of salaries and wages for all programs; and

4 WHEREAS, the fringe benefit amount required by the Community Health
5 Services to satisfy this mandate is \$88,136.00; and


6 WHEREAS, the Community Health Services performed a budget analysis
7 and determined budgeting for the additional 16% would have
8 an unacceptable negative impact in delivery of services
9 by the program; and

10 WHEREAS, the Community Health Services hereby requests \$88,136.00
11 to supplement the program budget to meet the costs of
12 increased fringe benefits.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
14 Council does hereby approve the Supplemental request and
15 authorizes expenditures in accordance with the attached
16 budget.

17 The foregoing Resolution was passed by the Tohono O'odham Council
18 on the 10th. day of September, 1990 at a meeting at which a
19 quorum was present with a vote of 1,502.5 for; 221.5 against;
20 -0- not voting; 02 absent, pursuant to the powers vested in the
21 Council by Section 1 (d)(2)(3) of Article VI of the Constitution
22 of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation
23 on January 18, 1986, and approved by the Acting Deputy Assistant
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
25 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
