11	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
12	Council does hereby approve the proposal for Children's
13	Initiative Funds.
14	BE IT FURTHER RESOLVED that the duration of this contract is
15	September 30, 1990 through September 30, 1991.
16	BE IT FURTHER RESOLVED that the Tohono O'odham Nation hereby
17	requests Indian Health Service to modify the Tohono
18	O'odham Psychological Services contract No. 249-90-0002
19	to incorporate the attached work plan and budget.

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Officials, to wit: The

Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the contract,

provided however, that any amendments affecting the

funding or funding levels of this contract shall be

submitted for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 10th. day of September, 1990 at a meeting at which a quorum was present with a vote of 1,671.0 for; 53.0 against; -0- not voting; 02 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
