RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Authorizing Execution of Service Line Agreement)

RES. NO. 29-90

WHEREAS, the Legislative Council did by Resolution No. 315-89 authorize the execution of a lease on behalf of the Nation with the San Xavier Cooperative Association, Inc. ("Association"), leasing to the Association, tribal land within the proposed San Xavier Cooperative Association Farm ("Farm"); and

WHEREAS, by federal regulation, 25 C.F.R. §169.22, the Association, as the legally authorized occupant or user of the leased tribal lands, is authorized to enter into service lines agreements to provide electric power to the leased land, provided the execution by the Association of the agreement has been duly authorized by the Legislative Council in advance of actual construction; and

WHEREAS, the Association did enter into a Service Line Agreement with the Papago Tribal Utility Authority ("PTUA"), as Applicant, a copy of which is attached hereto, pursuant to which PTUA has agreed to provide electric service to the Farm; and

WHEREAS, the Legislative Council approves of the Service Line Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby authorize and ratify execution of the Service Line Agreement with PTUA by the San Xavier Cooperative Association, Inc. in accordance with the requirements of 25 C.F.R. §169.22(b).

The foregoing Resolution was passed by the Tohono O'odham Council on the 6th. day of February, 1990 at a meeting at which a quorum was present with a vote of 1,667.0 for; -0- against; 57.0 not voting; 02 absent, pursuant to the powers vested in the Council by Section 1(c)(4) and (i) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
