

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorizing Execution of Service Line Agreement)

RES. NO. 29-90

1 WHEREAS, the Legislative Council did by Resolution No. 315-89  
2 authorize the execution of a lease on behalf of the  
3 Nation with the San Xavier Cooperative Association, Inc.  
4 ("Association"), leasing to the Association, tribal land  
5 within the proposed San Xavier Cooperative Association  
6 Farm ("Farm"); and

7 WHEREAS, by federal regulation, 25 C.F.R. §169.22, the  
8 Association, as the legally authorized occupant or user  
9 of the leased tribal lands, is authorized to enter into  
10 service lines agreements to provide electric power to the  
11 leased land, provided the execution by the Association  
12 of the agreement has been duly authorized by the  
13 Legislative Council in advance of actual construction;  
14 and

15 WHEREAS, the Association did enter into a Service Line Agreement  
16 with the Papago Tribal Utility Authority ("PTUA"), as  
17 Applicant, a copy of which is attached hereto, pursuant  
18 to which PTUA has agreed to provide electric service to  
19 the Farm; and

20 WHEREAS, the Legislative Council approves of the Service Line  
21 Agreement.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative  
23 Council that it does hereby authorize and ratify  
24 execution of the Service Line Agreement with PTUA by the  
25 San Xavier Cooperative Association, Inc. in accordance  
26 with the requirements of 25 C.F.R. §169.22(b).

27 The foregoing Resolution was passed by the Tohono O'odham Council  
28 on the 6th day of February, 1990 at a meeting at which a quorum  
29 was present with a vote of 1,667.0 for; -0- against; 57.0 not  
30 voting; 02 absent, pursuant to the powers vested in the Council  
31 by Section 1(c)(4) and (i) of Article VI of the Constitution of the  
32 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
January 18, 1986, and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
