

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Cooperative Agreement Between the Bureau of Indian Affairs
and Tohono O'odham Nation)

RES. NO. 303-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Headstart Program funded by the Department of Health and
3 Human Services; and

4 WHEREAS, P. L. 94-142, as amended by P. L. 99-457, the Education
5 of the Handicapped Act for American Indian children ages
6 three through five who live on reservations; and

7 WHEREAS, the intent of the Legislation for existing programs
8 serving handicap children work cooperatively in developing
9 and implementing inter-agency agreements to provide
10 services to handicapped children; and

11 WHEREAS, the Bureau of Indian Affairs and the Tohono O'odham Nation
12 did develop a formal agreement to provide handicap
13 services to children of the Tohono O'odham Nation; and

14 WHEREAS, the Tohono O'odham Headstart Program has submitted the
15 attached Agreement for review and approval by the Tohono
16 O'odham Legislative Council.

17 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does
18 hereby approve the Cooperative Agreement between the
19 Bureau of Indian Affairs and the Tohono O'odham Nation to
20 provide Handicap Services.

21 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
22 that the Tohono O'odham Nation's Officials, to wit: The
23 Chairman, Vice Chairman and any designated official are
24 hereby authorized to negotiate and execute the Agreement,
25 provided however, that any amendments affecting the
26 funding or funding levels of the Agreement shall be
27 submitted for further prior approval by this Council.

28 The foregoing Resolution was passed by the Tohono O'odham Council
29 on the 11th. day of September, 1990 at a meeting at which a quorum
30 was present with a vote of 1,610.0 for; -0- against; -0- not
31 voting; 04 absent, pursuant to the powers vested in the Council
32 by Section 1 (f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).


