

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Schuk Toak/San Xavier Pre-Design/Design
Contract No. 8-CS-32-00380 - Budget Modification No. 8)

1 WHEREAS, the Tohono O'odham Nation is presently operating the Schuk
2 Toak/San Xavier Pre-Design/Design Contract under P. L. 93-
3 638 with the Bureau of Reclamation; and

4 WHEREAS, any amendments affecting the funding and funding levels
5 of the contract shall be submitted for review and approval
6 by the Tohono O'odham Legislative Council; and


7 WHEREAS, an amendment has been submitted by the Tohono O'odham
8 Nation's Water Project Office for FY 1991 Administrative
9 costs for review and approval.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
11 Council does hereby approve the amendment to the Schuk
12 Toak/San Xavier Pre-Design/Design Contract.


13 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
14 that the Tohono O'odham Nation's Officials, to wit; the
15 Chairman, Vice Chairman and any designated official are
16 hereby authorized to negotiate and execute the contract,
17 provided however, that any amendments affecting the
18 funding or funding levels of this contract shall be
19 submitted for further prior approval by this Council.

20 The foregoing Resolution was passed by the Tohono O'odham Council
21 on the 11th day of September, 1990 at a meeting at which a quorum
22 was present with a vote of 1,610.0 for; -0- against; -0- not
23 voting; 114.0 (04) absent, pursuant to the powers vested in the
24 Council by Section 1 (f) of Article VI of the Constitution of the
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


