1 WHEREAS, the Schuk Toak District Council on September 5, 1990 did
2 approve their FY'91 Budget, by District Resolution No. ST-
3 9-5-90-2, in the amount of \$271,494.00; and


4 WHEREAS, the Schuk Toak District Council requests the Legislative
5 Council to ratify the budget; and

6 WHEREAS, the budgeted amount, upon ratification, be allocated to
7 be expended in accordance with the attached budget.


8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
9 Council that it does hereby approve the FY'91 Budget of
10 the Schuk Toak District in the amount of \$271,494.00 to
11 be expended in accordance with the attached budget.

13 on the 11th. day of September, 1990 at a meeting at which a quorum
14 was present with a vote of 1,550.5 for; -0- against; 59.5 not
15 voting; 114.0 (04) absent, pursuant to the powers vested in the
16 Council by Section 1 (d)(3) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
