

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Gu Achi District FY '91 Budget)

RES. NO. 308-90

1 WHEREAS, the Gu Achi District Council has considered and reviewed
2 its District Budget for FY 1990-91 and has prepared a
3 proposed budget to cover anticipated cost and expenses for
4 FY 1990-91; and

5 WHEREAS, the Gu Achi District Council did adopt and approve the
6 proposed budget for FY 1990-91 in the amount of
7 \$211,605.49; and

8 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
9 proposed budget and approves of same.

10 NOW, THEREFORE, BE IT RESOLVE by the Tohono O'odham Legislative
11 Council that it hereby approves the Gu Achi District
12 Council budget, in the amount of \$211,605.49, to be
13 expended in accordance with the attached budget.

14 The foregoing Resolution was passed by the Tohono O'odham Council
15 on the 11th day of September, 1990 at a meeting at which a quorum
16 was present with a vote of 1,610.0 for; -0- against; -0- not
17 voting; 114.0 (04) absent, pursuant to the powers vested in the
18 Council by Section 1 (d)(3) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




