1 WHEREAS, the Tohono O'Odham Legislative Council is aware of  
2 Public Law 100-497, the Indian Gaming Regulatory Act;  
3 and

4 WHEREAS, the Tohono O'Odham Legislative Council designated the  
5 Legislative Commerce Committee oversight of the Gaming  
6 Operation on the Tohono O'Odham Nation; and

7 WHEREAS, the National Indian Gaming Association is reviewing  
8 P. L. 100-497 at a conference to be held in Las Vegas,  
9 Nevada on February 27 & 28, 1990; and


10 WHEREAS, the National Indian Gaming Association is requesting  
11 tribal authorization for all participants at said  
12 conference; and

13 WHEREAS, the Commerce Committee motioned and approved for Andrew  
14 Patricio and John Reno to attend.

15 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham  
16 Legislative Council does hereby authorize Andrew  
17 Patricio and John Reno to attend the National Indian  
18 Gaming Association Conference on P. L. 100-497 on  
19 February 27 & 28, 1990 in Las Vegas, Nevada.

23 quorum was present with a vote of 1,724.0 for; -0- against;  
24 -0- not voting; and 03 absent, pursuant to the powers vested in  
25 the Council by Section 1(b) of Article VI of the Constitution  
26 of the Tohono O'odham Nation, adopted by the Tohono O'odham  
27 Nation on January 18, 1986, and approved by the Acting Deputy  
28 Assistant Secretary -Indian Affairs (Operations) on March 6,  
29 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
30 Stat. 984).
