

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Food Distribution and Family Nutrition Program)

RES. NO. 316-90

1 WHEREAS, the Tohono O'odham Nation has operated successfully a
2 program whereby the diet and nutritional needs of eligible
3 Tohono O'odham people have been served by supplementing
4 other federal social service programs; and

5 WHEREAS, the funding for the Tohono O'odham Food Distribution/
6 Family Nutrition Services has been provided through the
7 United States Department of Agriculture; and

8 WHEREAS, the continued operation of the Food Distribution Program
9 is essential to provide basic diet and nutrition for
10 eligible clients; and

11 WHEREAS, the Tohono O'odham Food Distribution Program has submitted
12 a budget for Fiscal Year 1991 for review and approval by
13 the Tohono O'odham Legislative Council.

14 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
15 Council that it hereby approves the application for
16 continuation of funding for the Tohono O'odham Food
17 Distribution Program.


18 BE IT FURTHER RESOLVED that the duration of this grant will be from
19 October 01, 1990 through September 30, 1991 unless
20 extended by mutual agreement of both contracting parties.

21 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
22 that the Tohono O'odham Nation will not fund or operate
23 the program in the interim while negotiations are still
24 being conducted and no executed grant has been awarded by
25 the United States Department of Agriculture.


26 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
27 that the Tohono O'odham Nation's Officials, to wit: The
28 Chairman, Vice Chairman and any designated official are
29 hereby authorized to negotiate and execute the grant,
30 provided however, that any amendments affecting the
31 funding or funding levels of this grant shall be submitted
32 for further prior approval by this Council.

The foregoing Resolution was passed by the Tohono O'odham Council on the 13th day of September, 1990 at a meeting at which a quorum was present with a vote of 1,724.0 for; -0- against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




