

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 1991 Food Distribution Program Supplemental Request)

RES. NO. 317-90

1 WHEREAS, the Tohono O'odham Nation does operate the Food
2 Distribution Program under a contract with the United
3 States Department of Agriculture; and

4 WHEREAS, the Food Distribution Program has been successful in
5 providing services to eligible O'odham members; and

6 WHEREAS, the Tohono O'odham Nation, by Resolution No. 154-90 has
7 mandated an increase in fringe benefit costs of an
8 additional 16% of salaries and wages for all programs; and

9 WHEREAS, the United States Department of Agriculture has informed
10 the Tohono O'odham Nation that any cost associated with
11 the Nation's building is the responsibility of the Nation;
12 and

13 WHEREAS, the Food Distribution Program has prepared a tribal
14 supplemental request to cover cost of the mandated fringe
15 benefits of \$25,157.40 and building cost of \$3,924.65 for
16 a total request of \$28,682.05.

17 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
18 Council does hereby the supplemental request of fringe
19 benefits and building costs and authorizes expenditures
20 in accordance with the attached budget entitled: Dollar
21 Match.

22 The foregoing Resolution was passed by the Tohono O'odham Council
23 on the 13th. day of September, 1990 at a meeting at which a quorum
24 was present with a vote of 1,502.5 for; 142.5 against; 79.0 not
25 voting; 03 absent, pursuant to the powers vested in the Council
26 by Section 1 (d)(2)(3) of Article VI of the Constitution of the
27 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
28 January 18, 1986, and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
30 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
