9	provision of services during FY 1991; and
10	WHEREAS, the Tohono O'odham Legislative Council has reviewed and
11	approved the Judicial Services Program recontract.
12	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13	Council that it does authorize and request the Bureau of
14	Indian Affairs to contract with the Tohono O'odham Nation
15	under P. L. 93-638 regulations and procedures for the
16	provision of services titled: Judicial Services
17	BE IT FURTHER RESOLVED that the duration of this contract will
18	commence on October 01, 1990 through September 30, 1991.
19	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
20	that the Tohono O'odham Nation will not fund or operate
21	the program in the interim while negotiations are still
22	being conducted and no executed contract extension has
23	been approved by the Bureau of Indian Affairs.
24	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
25	that the Tohono O'odham Nation's Officials, to wit: The
26	Chairman, Vice Chairman and any designated official are
27	hereby authorized to negotiate and execute the contract,
28	provided however, that any amendments affecting the
29	funding or funding levels of this contract shall be
30	submitted for further prior approval by this Council.
