

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Intergovernmental Agreement Between
Pima Community College and the Tohono O'odham Nation)

RES. NO. 321-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the JTPA
2 Program funded by the Department of Economic Security,
3 Department of Labor and Department of Health and Human
4 Services; and

5 WHEREAS, the J.T.P.A. Program has established a working
6 relationship with Pima Community College to provide
7 vocational skill training to eligible Tohono O'odham; and

8 WHEREAS, the Tohono O'odham Nation requires a formal Agreement to
9 be established to provide the services between Pima
10 Community College and the Nation's JTPA Program; and


11 WHEREAS, the J.T.P.A. Program has submitted for review and approval
12 the attached Agreement.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
14 Council does hereby approve the Intergovernmental
15 Agreement between Pima Community College and the Tohono
16 O'odham Nation.

17 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
18 that the Tohono O'odham Nation's Officials, to wit: The
19 Chairman, Vice Chairman and any designated official are
20 hereby authorized to negotiate and execute the Agreement,
21 provided however, that any amendments affecting the
22 funding or funding levels of this Agreement shall be
23 submitted for further prior approval by this Council.

24 The foregoing Resolution was passed by the Tohono O'odham Council
25 on the 13th. day of September, 1990 at a meeting at which a quorum
26 was present with a vote of 1,724.0 for; -0- against; -0- not
27 voting; 03 absent, pursuant to the powers vested in the Council
28 by Section 1 (f) of Article VI of the Constitution of the Tohono
O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
1986, and approved by the Acting Deputy Assistant Secretary -
Indian Affairs (Operations) on March 6, 1986, pursuant to Section
16 of the Act of June 18, 1934 (48 Stat. 984).
