

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(JOBS Title II Budget Modification No. 2)

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 JTPA/JOBS Title II Program funded by the Department of
3 Health and Human Services, Family Support Administration
4 (DHHS/FSA); and


5 WHEREAS, any amendments affecting the funding or funding levels of
6 the contract shall be submitted for review and approval
7 by the Tohono O'odham Legislative Council; and

8 WHEREAS, an amendment has been submitted for review and approval
9 by the JTPA/JOBS Title II Program.


10 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
11 that the Tohono O'odham Nation's Officials, to wit:
12 the Chairman, Vice Chairman and any designated official
13 are hereby authorized to negotiate and execute the
14 contract provided however, that any amendments
15 affecting the funding or funding levels of the contract
16 shall be submitted for further prior approval by this
17 Council.

18 The foregoing Resolution was passed by the Tohono O'odham Council
19 on the 13th day of September, 1990 at a meeting at which a quorum
20 was present with a vote of 1,724.0 for; -0- against; -0- not
21 voting; 03 absent, pursuant to the powers vested in the Council
22 by Section 1(f) of Article VI of the Constitution of the Tohono
23 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
24 1986, and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
26 16 of the Act of June 18, 1934 (48 Stat. 984).


