1 WHEREAS, the Tohono O'odham Legislative Council has reviewed the
2 San Xavier District fiscal year 1991 budget; and


3 WHEREAS, the Tohono O'odham Legislative Council has determined that
4 said budget is required for the adequate operation and
5 management of the San Xavier District; and

6 WHEREAS, sufficient funds have been identified to effect this
7 budget.


8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
9 Council hereby approves the fiscal year 1991 San Xavier
10 District budget in the amount of \$790,553.

11 The foregoing Resolution was passed by the Tohono O'odham Council
12 on the 13th day of September, 1990 at a meeting at which a quorum
13 was present with a vote of 1,610.0 for; -0- against; 114.0 not
14 voting; 02 absent, pursuant to the powers vested in the Council
15 by Section 1(d) (3) of Article VI of the Constitution of the Tohono
16 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,
17 1986, and approved by the Acting Deputy Assistant Secretary -
18 Indian Affairs (Operations) on March 6, 1986, pursuant to Section
19 16 of the Act of June 18, 1934 (48 Stat. 984).




