19	P.L. 99-503 investments to fund the \$91,645 budget.

23	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
24	to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
