	WHEREAS, on Monday, September 17, 1990 the Tohono O'odham
1	Legislative Council reviewed a preliminary partnership
2	proposal with Papago Oasis Enterprises for cable
3	television services for the Tohono O'odham Nation; and
4	WHEREAS, the proposal included expansion of Papago Oasis Enter-
5	prises to the mobile home park within the boundaries of
6	the San Xavier District of the Tohono O'odham Nation; and
7	WHEREAS, Papago Oasis Enterprises did not provide the Tohono
8	O'odham Legislative Council any financial information with
9	respect to the proposal; and
10	WHEREAS, it was recommended that this item be tabled pending
11	additional financial information and input from the San
12	Xavier District Council.
13	NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative
14	Council that it hereby refers this proposal to the
15	Commerce Committee and that Papago Oasis Enterprises
16	provide any pertinent financial information with respect
17	to this proposal.
18	BE IT FURTHER ORDERED that the Commerce Committee is to work in
19	conjunction with the San Xavier District with respect to
20	expanding cable services to its mobile home park located
21	within its boundaries.
22	The foregoing ORDER was passed by the Tohono O'odham Council on the
23	17th day of September, 1990 at a meeting at which a quorum was present with a vote of 1.724.0 for; -0- against; -0- not voting
