

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Charter Membership in National Indian Gaming Association)

RES. NO. 331-90

1 WHEREAS, the Tohono O'odham Legislative Council delegated the
2 Legislative Commerce Committee as the oversight on Indian
3 Gaming; and

4 WHEREAS, the Commerce Committee has actively participated in the
5 National Indian Gaming Association (NIGA) meetings; and

6 WHEREAS, the primary objective and purpose of the National Indian
7 Gaming Association is to promote, protect and preserve
8 Indian Gaming enterprises on Indian country; and

9 WHEREAS, the Commerce Committee recommends that the Tohono O'odham
10 Nation become a chartered member of NIGA; and

11 WHEREAS, the committee further recommends that Mary Ann Antone be
12 appointed as the official representative to the NIGA Board
13 of Directors.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
15 Council hereby approves the recommendation of the
16 Legislative Commerce Committee to establish its membership
17 in the National Indian Gaming Association.

18 BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council
19 appoint Mary Ann Antone as the official representative to
20 the National Indian Gaming Association Board of Directors.

21 BE IT FINALLY RESOLVED that the membership dues of \$1,200 be paid
22 from the Bingo revenues.

23 The foregoing Resolution was passed by the Tohono O'odham Council
24 on the 17th day of September, 1990 at a meeting at which a quorum
25 was present with a vote of 1,449.0 for; -0- against; 275.0 not
26 voting; 04 absent, pursuant to the powers vested in the Council
27 by Section 1 (b)(d)(2) of Article VI of the Constitution of the
28 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
29 January 18, 1986, and approved by the Acting Deputy Assistant
30 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
31 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
