

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Release of Monies - Credit and Finance Program)

RES. NO. 332-90

1 WHEREAS, the Legislative Council of the Tohono O'odham Nation has
2 established the Credit and Finance Program; and

3 WHEREAS, the Council has appropriated funds in the amount of
4 \$250,000.00 in FY '89 budget for the financing of
5 Entrepreneurs of the Tohono O'odham Nation (Res. No.
6 351-88).

7 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council carry
8 forward or appropriate \$250,000.00 for an Economic
9 Development line item into the Nation's FY '90 budget to
10 be released to that line item no later than September 30,
11 1990.

12 BE IT FURTHER RESOLVED that the Accounting Department will release
13 for deposit that sum of \$250,000.00 into a new account
14 called "Economic Development" at the First Interstate Bank
15 of Arizona.

16 BE IT FURTHER RESOLVED that this account will be maintained by the
17 Accounting Department of the Tohono O'odham Nation and
18 administered by the Credit Committee of the Credit and
19 Finance Program.

20 BE IT FURTHER RESOLVED that no funds shall be released or paid from
21 this account until the Legislative Council approves
22 policies and procedures for the expenditure of the funds,
23 including eligibility criteria for loans and the terms of
24 repayment.

25 The foregoing Resolution was passed by the Tohono O'odham Council
26 on the 18th. day of September, 1990 at a meeting at which a quorum
27 was present with a vote of 1,724.0 for; -0- against; -0- not
28 voting; 02 absent, pursuant to the powers vested in the Council
29 by Section 1 (d)(2) of Article VI of the Constitution of the
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
