3	provide legal services to the Nation with respect to the
4	land claims of the O'odham of Mexico; and
5	WHEREAS, the Contract term is from December 14, 1989 to September
6	30, 1990; and
7	WHEREAS, the funds appropriated and authorized for the Contract are
8	insufficient to cover Mr. Barnett's fees and expenses
9	through September 30, 1990; and
10	WHEREAS, the Domestic Affairs Committee and Budget & Finance
11	Committee have each approved a Modification to the
12	Contract budget and an amendment to the Contract which
13	increases the Contract budget by \$10,000, copies of which
14	are attached hereto.
15	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
16	Council hereby approves Amendment No. 1 to the Special
17	Counsel Agreement with George S. Barnett, in the form
18	attached hereto.
19	The foregoing Resolution was passed by the Tohono O'odham Council on the 19th day of September, 1990 at a meeting at which a quorum
20	was present with a vote of $1,229.5$ for; $59.5$ against; $435.0$ not voting; $03$ absent, pursuant to the powers vested in the Council
21	by Section $1(d)(2)$ & $(2)(1)$ of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation or
22	January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
