

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Amendment to the General Counsel Contract
with Strickland & Altaffer)

RES. NO. 345-90

1 WHEREAS, the Tohono O'odham Nation entered into a General Counsel
2 Contract with the law firm of Strickland & Altaffer (the
3 "Attorneys"), effective September 24, 1989 (the
4 "Contract"); and

5 WHEREAS, paragraph 3 (F) of the Contract provides that it expires
6 on December 18, 1990 (six months following the date the
7 Attorney General assumed office); and

8 WHEREAS, it is necessary for the proper conduct of the Nation's
9 legal affairs to retain the services of the Attorneys to
10 assure an orderly transition of legal matters to the
11 Office of Attorney General; and

12 WHEREAS, the remaining balance of the Contract budget is insuffi-
13 cient to pay the Attorneys' prior billing statements for
14 the period from March through August, 1990, together with
15 projected fees and expenses for September 1990; and

16 WHEREAS, the Attorney General has recommended an Amendment to the
17 Contract to increase the budgeted amount by \$40,000 to
18 cover the foregoing costs, and to make certain other
19 changes regarding supervision of the legal work; and

20 WHEREAS, the Domestic Affairs and Budget & Finance Committees have
21 approved a Modification No. 3 to the budget of the
22 Attorney General's Office to transfer the sum of \$40,000
23 to the Contract budget, and have further approved the
24 Contract Amendment in the form attached hereto.

25 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
26 Council hereby approves Modification No. 3 to the budget
27 of the Attorney General's Office, in the form attached
28 hereto, for the purposes of transferring the sum of
29 \$40,000 to the account established for the General Counsel
30 Contract with the law firm of Strickland & Altaffer; and

1 BE IT FURTHER RESOLVED THAT, the Tohono O'odham Legislative Council
2 hereby approves Amendment No. 1 to the foregoing Contract
3 in the form attached to this Resolution.

4 The foregoing Resolution was passed by the Tohono O'odham Council
5 on the 19th day of September, 1990 at a meeting at which a quorum
6 was present with a vote of 1,540.0 for; 184.0 against; -0- not
7 voting; 03 absent, pursuant to the powers vested in the Council
8 by Section 1(d)(2) & (2)(1) of Article VI of the Constitution of
the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
