

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting Projected Revenues of \$9,360,000 For FY-91)

RES. NO. 348-90

1 WHEREAS, the Budget and Finance Committee of the Legislative  
2 Council has reviewed the actual Revenues (attached) for  
3 FY-90 and have projected Revenues in the amount of  
4 \$9,360,000 for FY-91; and

5 WHEREAS, the Committee recommends adoption of these projections to  
6 fund the proposed FY-91 Budget of the Tohono O'odham  
7 Nation.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
9 Council that the attached projected revenues, in the  
10 amount of \$9,360,000 are hereby approved for the purposes  
11 of funding the Tohono O'odham Nation Budget for FY-91.

12 The foregoing Resolution was passed by the Tohono O'odham Council  
13 on the 26th. day of September, 1990 at a meeting at which a quorum  
14 was present with a vote of 1,724.0 for; -0- against; -0- not  
15 voting; 02 absent, pursuant to the powers vested in the Council  
16 by Section 1 (d)(2)(3) of Article VI of the Constitution of the  
17 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on  
18 January 18, 1986, and approved by the Acting Deputy Assistant  
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant  
20 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
