  Resources Committee for review.

  Committee is hereby authorized to confer with the

  Executive Office and the San Xavier District officials

  regarding this draft resolution.
- BE IT FURTHER ORDERED that the draft resolution be returned to the Tohono O'odham Legislative Council for reconsideration prior to the end of this General Session.
- The foregoing Order was passed by the Tohono O'odham Council on the 8th day of February, 1990 at a meeting at which a quorum was present with a vote of 1,603.5 for; 120.5 against; -0- not voting; 01 absent, pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
