

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Adopting FY-91 Budget for Executive Branch Established Programs  
in the Amount of \$4,050,399 and Employee Benefits  
in the Amount of \$951,187)

RES. NO. 349-90

1 WHEREAS, the current 1990 fiscal year for the Executive Branch and  
2 its established programs culminates at midnight, September  
3 30, 1990; and

4 WHEREAS, it is necessary for the continued administration of the  
5 Executive Branch to adopt an operation budget prior to the  
6 inception of the new fiscal year; and

7 WHEREAS, the Executive Branch of the Nation has conducted a  
8 detailed and comprehensive review and analysis of the  
9 fiscal needs of its branch for FY-91; and

10 WHEREAS, the Executive Branch has prepared and presented a budget  
11 reflective of their analysis for FY-91 operations; and

12 WHEREAS, the Executive Branch budget adopts a format consistent to  
13 a uniform format concurred to by the Legislative,  
14 Executive, and Judicial Branches; and

15 WHEREAS, the approved format transfers cost for Capital  
16 Expenditures, Employee Benefits and Major Repairs/  
17 Renovations to separate consolidated accounts, to be  
18 administered by the Executive Branch on behalf of the  
19 Nation as a whole; and

20 WHEREAS, the Legislature approves of the Executive Branch FY 1991  
21 budget as submitted.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
23 Council that the Executive Branch FY-91 budget, in the  
24 amount of \$4,050,399 is hereby approved and adopted, to  
25 wit:

The foregoing Resolution was passed by the Tohono O'odham Council on the 26th. day of September, 1990 at a meeting at which a quorum was present with a vote of 885.0 for; 839.0 against; -0- not voting; 03 absent, pursuant to the powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
