

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Tohono O'odham Judicial Branch FY-91 Budget  
in the Amount of \$846,390 and Employee Benefits  
in the Amount of \$181,009)

RES. NO. 350-90

1 WHEREAS, the current 1990 fiscal year for the Judicial Branch and  
2 its departments culminates at midnight, September 30,  
3 1990; and

4 WHEREAS, it is necessary for the continued administration of the  
5 Judicial Branch to adopt an operation budget prior to the  
6 inception of the new fiscal year; and

7 WHEREAS, the Judicial Branch of the Nation has conducted a  
8 detailed, comprehensive review and analysis of the fiscal  
9 needs of its branch for FY-91; and

10 WHEREAS, the Judicial Branch has prepared and presented a budget  
11 reflective of their analysis for FY-91 operations; and

12 WHEREAS, the Judicial Branch budget adopts a format consistent to  
13 a uniform format concurred to by the Legislative,  
14 Executive, and Judicial Branches; and

15 WHEREAS, the approved format transfers cost for Capital  
16 Expenditures, Employee Benefits and Major Repairs/  
17 Renovations to separate consolidated accounts, to be  
18 administered by the Executive Branch on behalf of the  
19 Nation as a whole; and

20 WHEREAS, the Legislature approves of the Judicial Branch FY-91  
21 budget as submitted.

22 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
23 Council that it hereby approves the Judicial Branch FY-91  
24 Budget, in the amount of \$846,390.

25 BE IT FURTHER RESOLVED that all costs for Capital Equipment,  
26 Employee Benefits in the amount of \$181,009, and Major  
27 Repairs/Renovations be transferred to separate  
28 consolidated accounts, to be administered by the Executive  
29 Branch on behalf of the Nation as a whole.

30 The foregoing Resolution was passed by the Tohono O'odham Council  
31 on the 26th. day of September, 1990 at a meeting at which a quorum  
32 was present with a vote of 1,441.5 for; 229.0 against; 53.5 not  
voting; 03 absent, pursuant to the powers vested in the Council  
by Section 1 (d)(2)(3) of Article VI of the Constitution of the

Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
