

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of O'odham In Mexico FY '91 Budget in the Amount
of \$145,455 and Employee Benefits in the Amount of \$25,082)

RES. NO. 354-90

1 WHEREAS, the current 1990 fiscal year for the O'odham In Mexico
2 Program culminates at midnight, September 30, 1990; and

3 WHEREAS, it is necessary for the continued administration of the
4 O'odham In Mexico Program to adopt an operation budget
5 prior to the inception of the new fiscal year; and

6 WHEREAS, the O'odham In Mexico Program of the Nation has conducted
7 a detailed, comprehensive review and analysis of the
8 fiscal needs of its office for FY-91; and

9 WHEREAS, the O'odham In Mexico Program has prepared and presented
10 a budget for its FY-91 operations; and

11 WHEREAS, the O'odham In Mexico Program budget is consistent to a
12 uniform format concurred to by the Legislative, Executive,
13 and Judicial Branches; and

14 WHEREAS, the approved format transfers cost for Capital
15 Expenditures, Employee Benefits and Major Repairs/
16 Renovations to separate consolidated accounts, to be
17 administered by the Executive Branch on behalf of the
18 Nation as a whole; and

19 WHEREAS, the Legislature approves of the O'odham in Mexico FY 1991
20 budget as submitted.

21 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
22 Council that it hereby approves the O'odham In Mexico
23 Program FY-91 budget, in the amount of \$145,455 .

24 BE IT FURTHER RESOLVED that all costs for Capital Equipment,
25 Employee Benefits in the amount of \$25,082.00, and Major
26 Repairs/Renovations be transferred to separate
27 consolidated accounts, to be administered by the Executive
28 Branch on behalf of the Nation as a whole.

29 The foregoing Resolution was passed by the Tohono O'odham Council
30 on the 26th. day of September, 1990 at a meeting at which a quorum
31 was present with a vote of 1,353.0 for; 163.0 against; 208.0 not
32 voting; 04 absent, pursuant to the powers vested in the Council
by Section 1 (d)(2)(3) of Article VI of the Constitution of the
Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
