

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Tohono O'odham Rodeo and Fair FY '91 Budget in the  
Amount of \$31,953 as recommended by the Executive Branch)

RES. NO. 355-90

1 WHEREAS, the current 1990 fiscal year for the Tohono O'odham Rodeo  
2 and Fair budget culminates at midnight, September 30,  
3 1990; and

4 WHEREAS, the Tohono O'odham Rodeo and Fair has prepared and  
5 presented a budget for its FY-91 operations; and

6 WHEREAS, the Tohono O'odham Rodeo and Fair budget is consistent to  
7 a uniform format concurred to by the Legislative,  
8 Executive, and Judicial Branches; and

9 WHEREAS, the approved format transfers cost for Capital  
10 Expenditures and Major Repairs/Renovations to separate  
11 consolidated accounts, to be administered by the Executive  
12 Branch on behalf of the Nation as a whole; and

13 WHEREAS, the Legislature approves of the Tohono O'odham Rodeo &  
14 Fair FY 1991 budget, provided that any and all funds  
15 generated or donated, including all existing funds, be  
16 accounted for through the Nation's Accounting Department,  
17 provided further that the appropriate committees, in  
18 conjunction with the Executive Branch, consider per diem  
19 for the Rodeo & Fair committee members.

20 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative  
21 Council that it hereby approves the Tohono O'odham Rodeo  
22 and Fair FY'91 budget, in the amount of \$31,953 provided  
23 that any and all funds generated or donated, including all  
24 existing funds, be accounted for through the Nation's  
25 Accounting Department, provided further that the  
26 appropriate committees, in conjunction with the Executive  
27 Branch consider, per diem for the Rodeo & Fair committee  
28 members.

29 BE IT FURTHER RESOLVED that all costs for Capital Equipment, and  
30 Major Repairs/Renovations be transferred to separate  
31 consolidated accounts, to be administered by the Executive  
32 Branch on behalf of the Nation as a whole.

The foregoing Resolution was passed by the Tohono O'odham Council on the 26th day of September, 1990 at a meeting at which a quorum was present with a vote of 1,610.0 for; 114.0 against; -0- not voting; 04 absent, pursuant to the powers vested in the Council by Section 1 (d)(2)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986, and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
