WHEREAS, the current 1990 fiscal year for the Tohono O'odham Psychological Services culminates at midnight, September 30, 1990; and

WHEREAS, it is necessary for the continued administration of the Tohono O'odham Psychological Services to adopt an operation budget prior to the inception of the new fiscal year; and

WHEREAS, the Tohono O'odham Psychological Services of the Nation has conducted a detailed, comprehensive review and analysis of the fiscal needs of its office for FY-91; and

WHEREAS, the Tohono O'odham Psychological Services has prepared and presented a budget for its FY-91 operations; and

WHEREAS, the Tohono O'odham Psychological Services budget is consistent to a uniform format concurred to by the Legislative, Executive, and Judicial Branches; and

WHEREAS, the approved format transfers cost for Capital Expenditures, Employee Benefits and Major Repairs/Renovations to separate consolidated accounts, to be administered by the Executive Branch on behalf of the Nation as a whole; and

WHEREAS, the Legislature approves of the Tohono O'odham Psychological Services FY 1991 budget as submitted.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby approves the Tohono O'odham Psychological Services FY-91 budget, in the amount of \$61,460 .

BE IT FURTHER RESOLVED that all costs for Capital Equipment, Employee Benefits in the amount of \$12,892, and Major Repairs/Renovations be transferred to separate consolidated accounts, to be administered by the Executive Branch on behalf of the Nation as a whole.

7 January 18, 1986, and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
9 to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
