

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Sells District Budget for FY '91)

RES. NO. 361-90

1 WHEREAS, the Sells District Council has in their District Council
2 \$602,339. plus to cover all the projected budget expenses
3 for fiscal year 1991; and

4 WHEREAS, the proposed budget of the Sells District Council has been
5 explained to the Legislative Body of the Tohono O'odham
6 Nation for their consideration and approval; and

7 WHEREAS, Tohono O'odham Legislative Council, under the Constitution
8 of the Tohono O'odham Nation, Article VI - Powers of the
9 Tohono O'odham Council, Section 1 (d)(3) has the power to
10 adopt, approval and amend annual budgets and to authorize
11 the expenditure of funds in accordance with these budgets.

12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative
13 Council that it hereby adopts the Sells District Council
14 Budget of \$168,662.00 for FY 1991.

15 The foregoing Resolution was passed by the Tohono O'odham Council
16 on the 27th day of September, 1990 at a meeting at which a quorum
17 was present with a vote of 1,724.0 for; -0- against; -0- not
18 voting; 04 absent, pursuant to the powers vested in the Council by
19 Section 1() of Article VI of the Constitution of the Tohono O'odham
20 Nation, adopted by the Tohono O'odham Nation on January 18, 1986,
21 and approved by the Acting Deputy Assistant Secretary - Indian
22 Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
23 the Act of June 18, 1934 (48 Stat. 984).




