

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Judicial Services Program - Budget Modification)

RES. NO. 366-90

1 WHEREAS, the Tohono O'odham Nation is presently operating the
2 Judicial Services Program under FY 1990 P. L. 93-638
3 Contract with the Bureau of Indian Affairs; and

4 WHEREAS, notification was received from the Bureau of Indian
5 Affairs advising the Tohono O'odham Nation that funds are
6 made available pursuant to P. L. 101-121, the Department
7 of the Interior and related agencies Appropriation Act,
8 1990; and

9 WHEREAS, such funds are available for obligation to reflect final
10 funding for FY 1990; and

11 WHEREAS, any amendments affecting the funding or funding levels of
12 the contract shall be submitted for review and approval
13 by the by the Tohono O'odham Legislative Council; and

14 WHEREAS, an amendment has been submitted for review and approval
15 by the Judicial Services Program.

16 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative
17 Council does hereby approve the amendment to the Judicial
18 Services contract and authorizes expenditures in accor-
19 dance with the attached budget.

20 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council
21 that the Tohono O'odham Nation's Officials, to wit: The
22 Chairman, Vice Chairman and any designated official are
23 hereby authorized to negotiate and execute the contract,
24 provided however, that any amendments affecting the
25 funding or funding levels of the contract shall be
26 submitted for further prior approval by this Council.

27 The foregoing Resolution was passed by the Tohono O'odham Council
28 on the 27th day of September, 1990 at a meeting at which a quorum
29 was present with a vote of 1,610.0 for; -0- against; -0- not
30 voting; 1114.0 (04) absent, pursuant to the powers vested in the
31 Council by Section 1 (f) of Article VI of the Constitution of the
32 Tohono O'odham Nation, adopted by the Tohono O'odham Nation on
January 18, 1986, and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant
to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
