

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1991 Food Distribution Program - Budget Modification)

RES. NO. 367-90

1 WHEREAS, the Tohono O'odham Nation did submit a contract proposal  
2 to the United States Department of Agriculture for Fiscal  
3 Year 1990; and

4 WHEREAS, notification was received from the United States  
5 Government of Agriculture advising the Tohono O'odham  
6 Nation that the proposed budget submitted would need to  
7 be modified as outlined in the Federal guidelines which  
8 may not exceed 30% of the total annual food cost; and

9 WHEREAS, any amendments affecting the funding or funding levels of  
10 the contract shall be submitted for review and approval  
11 by the by the Tohono O'odham Legislative Council; and

12 WHEREAS, an amendment has been submitted for review and approval  
13 by the Food Distribution Program.

14 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative  
15 Council does approve the amendment and authorizes  
16 expenditures in accordance with the attached budget  
17 submitted by the Food Distribution Program.

18 BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council  
19 that the Tohono O'odham Nation's Officials, to wit: The  
20 Chairman, Vice Chairman and any designated official are  
21 hereby authorized to negotiate and execute the contract,  
22 provided however, that any amendments affecting the  
23 funding or funding levels of the contract shall be  
24 submitted for further prior approval by this Council.

25 The foregoing Resolution was passed by the Tohono O'odham Council  
26 on the 27th. day of September, 1990 at a meeting at which a quorum  
27 was present with a vote of 1,618.0 for; -0- against; 106.0 not  
28 voting; 04 absent, pursuant to the powers vested in the Council  
29 by Section 1 (f) of Article VI of the Constitution of the Tohono  
30 O'odham Nation, adopted by the Tohono O'odham Nation on January 18,  
31 1986, and approved by the Acting Deputy Assistant Secretary -  
32 Indian Affairs (Operations) on March 6, 1986, pursuant to Section  
16 of the Act of June 18, 1934 (48 Stat. 984).
